However, if the Legislature has further environmental concerns regarding this project and needs additional information, the Presiding Officer should remand the case back to the initiating unit for the necessary changes to the project and EAF or submit a resolution authorizing the initiating unit to prepare a draft environmental impact statement (positive declaration).

WHEREAS, at its May 16, 2018 meeting, the Suffolk County Council on Environmental Quality (CEQ) reviewed the EAF and associated information submitted by the Suffolk County Department of Economic Development and Planning; and

WHEREAS, a presentation regarding the project was given at the meeting by Laretta Fischer, Chief Environmental Analyst, with the Suffolk County Department of Economic Development and Planning; and

WHEREAS, this project SEQRA review is for the proposed 2018 Suffolk County Agricultural District Modifications; and

WHEREAS, pursuant to NYS Agricultural Markets Law Section 303-b, the Suffolk County Agricultural and Farmland Protection Board, as part of its annual review process, reviewed 5 applications totaling 404 parcels of land for possible inclusion within certified Agricultural Districts; and

WHEREAS, the Suffolk County Agricultural and Farmland Protection Board, at its April 26, 2018 meeting, recommended that 400 parcels, which are indicated in the EAF, be included within certified Agricultural Districts; and

WHEREAS, the Suffolk County Agricultural and Farmland Protection Board determined that these 400 parcels are viable agricultural lands that would serve the public interest by assisting in maintaining a viable agricultural industry within the district; now, therefore, be it

1st RESOLVED, that based on the information received and presented, a quorum of the CEQ hereby recommends to the Suffolk County Legislature and County Executive that the proposed activity be classified as an Unlisted Action under the provisions of Title 6 NYCRR Part 617 and Chapter 450 of the Suffolk County Code; and, be it further

2nd RESOLVED, that based on the information received, a quorum of the CEQ recommends to the Suffolk County Legislature and County Executive, pursuant to Title 6 NYCRR Part 617 and Chapter 450 of the Suffolk County Code, that the proposed project will not have significant adverse impacts on the environment for the following reasons:

1. The proposed action will not exceed any of the criteria in Section 617.7 of Title 6 NYCRR which sets forth thresholds for determining significant effect on the environment, as demonstrated in the Environmental Assessment Form;
2. The proposal does not appear to significantly threaten any unique or highly valuable environmental or cultural resources as identified in or regulated by the Environmental Conservation Law of the State of New York or the Suffolk County Charter and Code;

3. The parcels do not appear to suffer from any severe environmental development constraints (limiting soil properties, a high groundwater table and/or unmanageable slopes);

CEQ RESOLUTION NO. 19-2018, RECOMMENDATION CONCERNING A SEQRA CLASSIFICATION AND DETERMINATION FOR THE PURPOSES OF CHAPTER 450 OF THE SUFFOLK COUNTY CODE FOR THE PROPOSED ROAD IMPROVEMENTS TO CR 21, YAPHANK-MIDDLE ISLAND ROAD FROM LONGWOOD MIDDLE SCHOOL TO NYS ROUTE 25, TOWN OF BROOKHAVEN

WHEREAS, at its May 16, 2018 meeting, the Suffolk County Council on Environmental Quality (CEQ) reviewed the EAF and associated information submitted by the Suffolk County Department of Public Works; and

WHEREAS, a presentation regarding the project was given at the meeting by Alex Gimpelman, Civil Engineer with the Suffolk County Department of Public Works; and

WHEREAS, the proposed project involves road improvements to CR 21, Yaphank Middle Island Road, from the Longwood Middle School to NYS Route 25; and

WHEREAS, these road improvements include providing continuous curb and sidewalks on both sides of the roadway for improved pedestrian safety mobility and the widening of the roadway within the existing right-of-way to provide shoulders and left turn lanes where necessary for improved safety and mobility for both motorized and non-motorized roadway users; and

WHEREAS, the proposed road improvements also involves construction of a left turn lane and traffic signal upgrades at the Longwood Middle School to provide operational improvements at this intersection; and

WHEREAS, the project may also include ancillary work to be performed by various utility companies, which may include relocating underground and/or overhead electric, underground and/or overhead telephone/communications, and underground gas, water, and/or sewer infrastructure as necessary to construct the proposed roadway improvements; and

WHEREAS, the project also includes the replacement and upgrade of an existing stormwater outfall pipe to the proximity of the Carmans River headwaters which involves replacing the existing 15 inch corrugated metal pipe with a 24 inch polyethylene pipe and a stormwater treatment structure; and

WHEREAS, this project, with the exception of the replacement of the outfall pipe, was reviewed by CEQ and Legislature in 2016 and received a SEQRA Negative Declaration via Suffolk County Resolution 776-2016; and

WHEREAS, this updated SEQRA review is being done so that the replacement of the outfall pipe is also considered as part of the overall road improvement project; now, therefore, be it

1st RESOLVED, that based on the information received and presented, a quorum of the CEQ hereby recommends to the Suffolk County Legislature and County Executive that the proposed activity be classified as an Unlisted Action under the provisions of Title 6 NYCRR Part 617 and Chapter 450 of the Suffolk County Code; and, be it further

2nd RESOLVED, that based on the information received, a quorum of the CEQ recommends to the Suffolk County Legislature and County Executive, pursuant to Title 6 NYCRR Part 617 and Chapter 450 of the Suffolk County Code, that the proposed project will not have significant adverse impacts on the environment for the following reasons:

1. The proposed action will not exceed any of the criteria set forth in Title 6 NYCRR Part 617.7 which sets forth thresholds for determining significant effect on the environment, as demonstrated in the Environmental Assessment Form;
2. The proposed action does not appear to significantly threaten any unique or highly valuable environmental or cultural resources as identified in or regulated by the Environmental Conservation Law of the State of New York of the Suffolk County Charter and Code;
3. The replacement of the outfall pipe will include a new stormwater treatment structure that will treat the stormwater before it is discharged to the proximity of the Carmans River headwaters;
4. The area where the outfall pipe and headwall is removed and replaced will be regraded and restored with suitable native woodland seeding and groundcover;
5. All necessary State permits and approvals, including from the New York State Department of Environmental Conservation, will be obtained prior to the commencement of project construction activities;
6. The proposed construction will be of temporary duration and will be coordinated with the Longwood Middle School so that the heavy construction activities such as milling, pavement removals and paving are performed during evenings, weekends or periods when the school does not have peak activities scheduled;
7. The proposed improvements to the County Road 21 will improve vehicular safety, pedestrian safety and stormwater management along the road corridor;
